Boldyn End-User Agreement

This Boldyn_End User Agreement ("EUA") is a legal agreement entered into between Boldyn Networks Higher Ed LLC (formerly known as Apogee Telecom, Inc. End Users are bound to the terms provided herein.

YOU ACKNOWLEDGE AND AGREE THAT (1) YOU HAVE READ THIS EUA; (2) YOU UNDERSTAND IT; (3) YOU ARE BOUND BY IT; (4) YOU HAVE READ THE CAMPUS PRIVACY POLICY REFERENCED BELOW; AND (5) WE MAY UPDATE THIS EUA AT ANY TIME AND WILL PROVIDE NOTICE ON YOUR SERVICE PORTAL OR VIA OTHER REASONABLE MEANS (find your school portal at https://campus.hed.boldyn.com/select). IF YOU DO NOT AGREE TO THE FOREGOING, YOU AGREE THAT YOU DO NOT HAVE A LICENSE TO, AND YOU WILL NOT USE, THE SERVICES.

Changes to this EUA. Boldyn can change, update, add or remove provisions of this EUA at any time by posting the updated EUA on the portal (find for your school at https://campus.hed.boldyn.com/select)

and by providing a notice through the service. We will ask for your express consent to the updated EUA when and where we are legally required to do so. If you do not agree with any of the updated EUA, you must stop using the service. Continued use of the service following notice of any such modifications indicates you acknowledge and agree to be bound by the modifications. Unless otherwise required by law, the updated EUA is effective as of the day of posting.

Changes to the Service. Boldyn may make changes to the service at any time, without notice to you. If you object to any changes to the service, your sole recourse will be to cease using the service.
